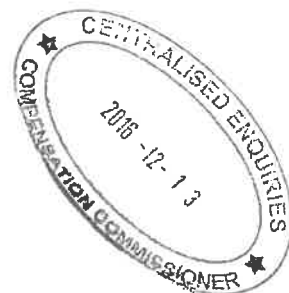
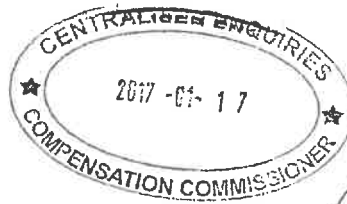

Unfortunately there is no given time frame for a Reclassification to be done at the Compensation Fund. Please find herewith the Letter covering until the updated Letter of Good Standing from the Compensation Commissioner is received.

Section 89(1) of the Compensation Act specifically addresses the relationship between Mandators and Contractors and it is for this purpose that a Mandator typically insists on a Letter of Good Standing from the contractor.

The Commissioner has implemented drastic changes to his process of issuing Letters of Good Standing in an effort to curb fraud. Unfortunately, this has had a negative and unforeseen impact on numerous employers who are either fully compliant or who, through no fault of their own, are part of the backlog in the raising of assessments and correction of mistakes.

Please be assured that, in terms of the Act, an employee will always be entitled to the benefits in terms of the Act, irrespective whether an employer can obtain a valid Letter of Good Standing or not and these current developments do not affect the functioning of the claims sections at the Compensation Fund.
